\* By pre-registering and paying seasonal fees by May 30, 2015 you receive 15% off the weekly rate.

\* Please submit your stall plans with your application.

\* Stall fees shall be paid to the Market Manager or other designated person. Daily fees will be paid by the end of the market day.

\* The registration form, together with a non-refundable deposit of \$200.00 will be necessary to guarantee seasonal stall space. Funds will be applied to the seasonal fee.

\* Upon receipt of the \$200 registration fee, stalls will be let on a seasonable basis. The Market Manager reserves the right to make the final assignment of the stalls. The Market Manager reserves the right to reject or refuse any vendor.

\* To guarantee a reservation for a one-time market attendance, a full (non-refundable) deposit is required.

\* N.S.F. cheques will be subject to a bank charge and payment must be made good within 15 days. Failure to comply will result in termination of your rental agreement with the market effective immediately after the 15 day time period.
